

#### **Public Input Survey Results**


- The survey was open from July 13<sup>th</sup> October 1<sup>st</sup>





#### Q3: How familiar are you with the Site?









## Q7: How are you associated with the Town of Navassa? Please check all that apply.





## Q8: How many people in your household fall within each of the following age categories?




